- (1) Hartford Jai Alai closed September 5, 1995. An off-track betting branch continues to operate at that site until April 15, 2002..
- (2) An Off-Track Betting branch was opened in the Milford fronton in October, 1993.
- (3) PA 91-309 authorized the conversion of the Bridgeport Jai Alai to a greyhound racing facility.
- (4) PA 92-17(MSS) authorized one additional simulcasting facility at the Bridgeport Jai Alai or dog track. It opened in October, 1993.
- (5) Bridgeport Jai Alai held its last jai alai performance on April 30, 1995, and was subsequently converted to a greyhound racing facility, Shoreline Star Greyhound Park, which opened on November 1, 1995.
- (6) Connecticut Jai Alai, Inc. (Milford Jai Alai) ceased operations December 12, 2001.
